The Registrar may, on receiving your notification, arrange for the application to be set down for a formal hearing before a judge. Where a determination or order has already been made by a registrar, affected persons may also apply to the court to seek a review of that determination or order. A review must be lodged within 20 working days after the determination or order is made or, at the satisfaction of a judge, within a longer period.
